

Hunan City College 2024 General University Admission Regulations

Chapter I General Provisions

Article 1 This Charter is formulated in accordance with the Education Law of the Peoples Republic of China, the Higher Education Law of the Peoples Republic of China and other laws and regulations and relevant provisions of the Ministry of Education, taking into account the actual enrollment work of the university.

Article 2: The full name of the school is Hunan City College

School location: No.518 Yingbin East Road, Yiyang City, Hunan Province. Supervisory department: Hunan Provincial Department of Education

Education level: Undergraduate Institution National code: 11527 Type of education: Public

Article 3 The name of the school that issues the academic certificate: Hunan City University. The type of certificate: Full-time undergraduate graduation certificate of ordinary higher education institutions. Those who meet the conditions for degree granting shall be granted the corresponding bachelors degree.

Article 4 The schools enrollment work shall follow the principles of "fair competition, fair selection and open transparency", resolutely implement the enrollment policy provisions and disciplinary requirements, and strictly implement the "sunshine project" of examination and enrollment.

Article 5: The school is a provincial public full-time ordinary undergraduate higher education institution approved and established by the Ministry of Education, and it is a first-batch undergraduate admission university in Hunan Province and a masters degree granting institution. The school possesses national-level co-creation spaces, postdoctoral research station collaborative R&D centers, the first batch of national comprehensive

reform pilot programs, and a national experimental teaching demonstration center for civil engineering, among other teaching and research platforms. It is a model university for national graduate employment experience and a high-level applied characteristic college under Hunan Provinces "Double First-Class" initiative.

Article 6 Categories of school enrollment: general (including public teacher students starting from high school and excellent students)The teacher training program, vocational high school counterpart, southern Xinjiang single listing, Xinjiang orientation), art (including Sino-foreign cooperative education), physical education, Chu Yi Craftsman program. The final enrollment category shall be subject to the documents issued by the superior competent authorities.

Chapter II Organization management

Article 7 The schools enrollment work leading group shall be responsible for studying and deciding on major matters such as enrollment scale determination and policy formulation, and the schools enrollment and employment office shall be responsible for the daily work of organizing and implementing enrollment.

Article 8 During the period of enrollment and admission, the schools disciplinary inspection and supervision institutions shall supervise the enrollment and admission work throughout the whole process to ensure that it is standardized, orderly, fair and just.

Article 9 The school strictly implements the policies and disciplinary requirements of the Ministry of Education and the Hunan Provincial Department of Education. The school has not cooperated with any social organizations or individuals, nor has it entrusted any social organization to recruit students. Any social organization or individual that promotes cooperation with our school or claims that admission can be guaranteed through "internal quotas" should be reported to the education authorities immediately. Those who suffer related losses may report to the public security authorities.

Article 10 The university will strictly implement the enrollment policy and

discipline. For candidates and staff who violate the enrollment regulations, they will be dealt with in accordance with the Measures for Handling Violations of National Education Examination (Ministry of Education Order No.33) and the Interim Measures for Handling Violations of Enrollment Regulations in Ordinary Higher Education Institutions (Ministry of Education Order No

Chapter III Enrollment Plan

Article 11 The school will recruit students from 30 provinces in 2024. The Admissions and Employment Office will compile provincial and major-specific recruitment plans based on the enrollment plans and requirements issued by the higher authorities, and report them to the relevant provincial (autonomous region, municipality) ordinary higher education admission offices. The specific recruitment categories, majors, and plans will be based on the information published by the education authorities of the source provinces (municipalities, autonomous regions). According to the relevant regulations of the Ministry of Education and the Hunan Provincial Department of Education, the schools reserved plan will not exceed the total enrollment plan 1% is used to adjust the imbalance of students who pass the unified examination in each province (region, municipality) and solve the admission problem of candidates with the same score.

Article 12 The schools majors for admission in 2024

Note: The specific majors and related categories for enrollment in each province will be announced by the enrollment examination authorities of each province after the enrollment plan of our university is determined by province and major.

Article 13 The university cooperates with Victoria Polytechnic College (Whitireia Community Polytechnic, New Zealand) in New Zealand to run an undergraduate program in Visual Communication Design (Sino-foreign cooperative education).

The Visual Communication Design (Sino-Foreign Cooperative Education) program is included in the national general higher education enrollment plan with a 4-year academic system. Students participate in the national unified entrance examination for general higher education institutions and are admitted

After graduation, students will adopt a 3+1 joint training model, studying at our university for the first three years, and in the fourth year, students can choose to study abroad at Victoria Polytechnic or continue their studies at our university. If they choose to study abroad and meet the relevant degree awarding regulations of Victoria Polytechnic, they can obtain a Bachelor of Applied Arts in Visual Arts and Design from the university. If they meet the relevant regulations of our university, they will be awarded a Full-time Ordinary Undergraduate Diploma and Bachelors Degree from our university; if they choose to complete their studies at our university, and meet the relevant regulations of our university, they will be awarded a Full-time Ordinary Undergraduate Diploma and Bachelors Degree from our university.

Chapter V Admission Rules

Article 14: The school determines the file adjustment ratio based on the student enrollment situation in each province (autonomous region, municipality). For the batch of sequential preference, the file adjustment ratio is controlled within 110%; for the batch of parallel preference, the file adjustment ratio is controlled within 105%. The file adjustment principles are implemented according to the regulations set by the education authorities of the students enrollment province (autonomous region, municipality).

In Inner Mongolia Autonomous Region, "the enrollment plan is 1:1 and students are ranked according to their professional preferences within the scope."

Article 15 The school selects students based on their total college entrance

examination scores, taking into account the comprehensive quality evaluation of ordinary high school students, and admits students on a merit basis. For the professional placement of candidates who meet the admission criteria, the principle of "score priority, following preferences, no professional score difference" is applied, combined with the candidates physical examination results from the college entrance examination, to sequentially select and admit students on a merit basis. In case of equal scores, candidates are admitted according to the same-score ranking rules of their respective provinces; if there are no same-score ranking rules, candidates are ranked and admitted based on their scores in Chinese, Mathematics, and English from high to low, with English scores being given priority for admission to English-related majors. If none of the candidates professional preferences can be met, and if they agree to professional adjustment, they will be adjusted to other majors that meet the conditions and have unfilled quotas (in provinces with college entrance examination reforms, adjustments are limited to the same major group); if they do not agree to professional adjustment, It will be treated as a withdrawal.

Article 16 The university recognizes the relevant regulations on bonus points or deduction points issued by the education departments of provinces (autonomous regions, municipalities).

Article 17 The school recognizes the results of the unified art examinations (joint examinations) organized by each province (autonomous region, municipality). When making admissions, the candidates scores in the college entrance examination and professional unified examinations (joint examinations) must reach the minimum admission control line for the corresponding level of art majors set by the candidates province (autonomous region, municipality). The admission ratio and method shall be subject to the regulations set by the education authorities of the candidates province (autonomous region, municipality).

The admission principle is: for candidates who meet the file requirements, they are admitted according to the comprehensive score of the source province from high to low;

for those not admitted based on the comprehensive score, they are ranked and admitted according to the comprehensive score (total college entrance examination score \times 30% + major score \times 70%) from high to low, in case of identical comprehensive scores, candidates with higher major scores are given priority, if the major scores are still the same, then they are ranked and admitted according to the single subject scores of Chinese, Mathematics, and English from high to low.

Article 18 Candidates applying for sports-related majors must meet the professional score and college entrance examination cultural score requirements respectively, which must reach the admission control line for sports majors in their respective provinces (autonomous regions, municipalities). Within the range of candidates eligible for admission, candidates will be ranked and admitted according to their ranking scores from the highest to the lowest in their respective provinces (autonomous regions, municipalities). In case of identical ranking scores, candidates with higher professional scores will be given priority for admission.

Article 19 The major of Visual Communication Design (Sino-foreign cooperative education) shall implement the admission of professional preferences, and no candidates who do not fill in the professional preference for this major will be subject to professional adjustment.

Article 20 English and Business English are limited to candidates whose native language is English. Other majors do not restrict the foreign language, but in principle, the public foreign language courses of the university are only taught in English.

Article 21 The school offers a Business Administration Minor program for students from non-management majors to pursue. Upon completing the required credits and obtaining the degree of the major discipline, students will also be awarded a Bachelor of Science in Management (Minor). Matters related to the cultivation of dual degrees and management shall be conducted in accordance with the relevant regulations of the Ministry of Education, Hunan Provincial Department of Education, and the school.

Article 22 In provinces (autonomous regions and municipalities directly under the Central Government) involved in college entrance examination reform, candidates shall

meet the requirements of subject selection when applying for admission, otherwise they will not be admitted. The use method of comprehensive quality evaluation shall refer to the teaching The relevant documents of the Ministry of Education shall be implemented.

Article 23 The school shall not limit the ratio of male to female.

Article 24: New students shall complete the registration procedures according to the time and requirements specified by the school. Those who have been admitted but cannot report on time must submit a written application to the schools admissions office and obtain approval before any extension can be granted. The extension period shall not exceed two weeks in principle. Students who fail to report on time for one week without approval will be deemed to have abandoned their admission qualifications and will not be registered for academic status.

Chapter VI Supplementary Provisions

Article 25 The school strictly implements the relevant regulations on student transfer issued by the Ministry of Education. Those who need to change their majors shall follow the "Hunan City University Full-time Ordinary Undergraduate Students Major Change Management Measures".

Article 26 The school has established a comprehensive and multi-channel financial aid system including scholarships, grants, loans, work-study programs, subsidies, and exemptions. Students from economically disadvantaged families can apply for student loans based on their place of origin. The school provides assistance through measures such as work-study programs and special hardship grants in accordance with relevant policies, regulations, and procedures. The school encourages students to complete their studies through various means, including work-study programs and scholarships.

Article 27 The school implements the credit system for tuition fees, and the tuition fees shall not exceed the total tuition fees of the academic year. According to the principle of territorial management, the school strictly charges according to the standards

set by the Hunan Provincial Development and Reform Commission, the Hunan Provincial Finance Department and the Hunan Provincial Education Department.

Article 28 The physical examination standards for the admission of candidates shall be implemented in accordance with the Guidelines on Physical Examination for the Admission of Candidates to Ordinary Higher Education Institutions issued by the Ministry of Education, the former Ministry of Health and the China Disabled Persons Federation and relevant supplementary provisions.

Article 29 The ideological and political quality assessment and physical health examination of the admitted candidates shall be based on the information collected when they apply for the general college entrance examination or the corresponding recruitment examination, and students shall be responsible for the authenticity of the information provided.

Article 30 Within 3 months after the enrollment of a new student, the school shall, in accordance with the enrollment policy, examine the eligibility of the new student, his or her physical and mental condition, the procedures and procedures for enrollment, the eligibility for enrollment, the preferential eligibility and related matters The school will conduct a re-examination and review of the certification materials and other relevant documents. For any issues identified during the re-examination and review, the school will conduct a concentrated study and handle them. Any case of falsification will result in the revocation of admission eligibility upon verification. For cases involving serious falsification or suspected identity theft in university enrollment, the matter will be referred to relevant departments for investigation and handling.

Article 31 This Charter shall be released to the public through the "Sunshine College Entrance Examination" platform and the schools official website. If there is any misunderstanding of the contents of the charter published by various media, the complete enrollment charter published by the school shall prevail.

Article 32 This Charter applies to the 2024 general higher education admission of our university. The interpretation right belongs to the Admissions and Employment Office of Hunan City University. In case of adjustments to higher education admission policies

by the higher authorities, the latest published policies shall prevail.

Regulations on the management of online admission sites for the 2024 general college entrance examination

In order to ensure the orderly online admission of ordinary college entrance examination in our school and do a good job in the confidentiality of admission information, we hereby formulate the following management regulations according to the relevant requirements of admission work:

1. The admission site shall be closed, and all staff members shall enter and leave with work certificates. No one who has nothing to do with the enrollment shall enter the admission site.

2. No visitors are allowed at the admission site. Candidates, their parents and school staff are arranged in the reception room by the recruitment and employment office, and they are not allowed to enter the admission site.

3. It is strictly prohibited to repair the application form, login query and modify the candidate information without authorization. The data that needs to be modified must be approved by the principal leader and the head of the enrollment office before modification.

4. Keep the network open and the equipment running normally. Do not use the enrollment equipment without authorization, download and install software unrelated to online enrollment, and browse web pages unrelated to online enrollment.

5. It is strictly prohibited to leak the relevant admission information of the recruitment site, and it is strictly prohibited to take out the admission materials that have not been approved for public disclosure.

6. School leaders and staff at all levels should consciously abide by the management regulations of the site of enrollment and admission.

7. The relevant departments of the school should assist in the management of the admission site to ensure that the network is open and the water and electricity supply is normal.

8. Fire and theft prevention to prevent accidents.

Hunan City College general college entrance examination online admission file reading notice

The online admission staff mainly check the following information when reviewing the files:

一、Registration information:

1. Check when and where the candidate has received any rewards or punishments;
2. Opinion on moral and ideological assessment.

二、Results and preferences: quick lookup.

三、Physical examination information:

1. Past medical history;
2. Check whether there are any abnormal conditions;
3. Check the opinion of the hospital or checkpoint (whether it meets the requirements of the major to be admitted, and height, weight and other factors shall not be used as restrictions on admission).
4. If any abnormal situation is found during the review of the file, please register it in the Review Opinion Form and sign it.
